	Mick reported that we have bought 40 chairs from the village hall for approx £3 each.	
	Car Park - Mick updated the committee on the response of the Parish Council. They will not give the Club the £1,000 promised until we have paid the contractor and there are also 'conditions' attached to this which have not yet been explained. Consequently we will have to pay the VAT element which, in the past, the Parish Council have claimed back. The committee expressed its disappointment with the way the Parish Council had handled the matter and a corporate resignation was discussed.	
	Peter proposed we pay the contractor as a matter of urgency and Dibby will liaise with Peter and get the cheque to Rosemary to send off with an apology for the lateness. Rosemary will also write a letter to the Parish Council informing them of the committee's concerns and agreeing that we need a meeting with them. Unfortunately, Peter will be on holiday until 18 February and, since he needs to be present, it will have to wait until he comes back.	DS/PB RM
	It was mentioned that there had been a private function the previous Sunday with several cars and parking space was adequate. Keith reported that Lea Sports are also happy with the new car park.	:
3.	Reports	
	<b>Treasurer</b> - Peter handed out the accounts and explained them. He is slightly concerned as there has not been a bill from Powergen for some time and the meter has not been read either. He therefore proposed that once the Greene King loan is paid off in the very near future he will put the monthly payment of £150 in a separate account as a contingency fund.	РВ

We have £10,000 in the business account and £2,800 in the Courts account.

**Tennis Section** - John reported that £750 had been paid to Peter and there is another meeting soon to sort out membership. The section has plans for matches and leagues in the coming year.

It was mentioned that the MUGA surface needs cleaning and a moss treatment applied at least once a year. This will cost in the region of £800 per year and we will need three quotes. John will arrange to get quotes and we could ask the Parish Council to contribute.

#### 1. Parish Council Visit

O Lister introduced the Parish Council members and summarised the problem as they see it. They are not happy with the fact that the Sports & Social Club committee went ahead with the car park work without presenting them with a proper plan of what was to be done. They are also not happy with the actual work itself and J Bhomick said he had spoken to Mick and agreed to sort it out and roller it.

Peter put forward the Club's position pointing out that the Parish Council had done little or nothing about the condition of the car park and, although our improvement was not perfect, it was better than it had been. He also commented that the recreation ground is, in fact, owned by the Parish Council and its very easy to criticise when other people do the work. We also do not have the resources to do the car park to Highways standard anyway.

O Lister said he thought we had agreed to spend a small amount of money to sort it out but, as far as we are concerned, that's not the case - we are happy with the car park, it is the Parish Council who are not. R Hamilton-McLeod asked how much the extra work would cost and Mick said that nothing had been agreed. She proposed that the works J Bhomick recommended should be done and this will amount to approximately £1,000. The Parish Council have not agreed how much could be put forward for the works or whether it could wait until next year. It was made clear that the Club certainly cannot afford to do anymore work but agreed that the markers for the pathway need to be put in and the gate to the play area re-sited.

R Hamilton-McLeod asked if we would object if they want to do improvements. Agreed we wouldn't object but we can't afford to do any more work.

Peter pointed out that both organisations are working toward the same goals, but its been strongly felt that the Parish Council have been over-critical of the work on the car park. It should be remembered that the Sports and Social Club is run by volunteers and, if the committee resigned en masse, the Parish Council would be totally responsible for the upkeep of the clubhouse and recreation ground. O Lister said he sees us as the management committee and the Parish Council as the owners.

R Hamilton-McLeod said one of the reasons for the meeting was to work more closely together and she promised to try to forge a better relationship. We need to get rid of the present problem and agree clearer guidelines for dealing with this type of work in the future. Mick pointed out that this problem has actually cost the Club approximately £200 more than it need have.

O Lister asked if we wanted to discuss the remedial works later or now. The committee think the car park is basically adequate and nothing is needed apart from the posts being put down and the fencing straightened.

The Parish Council require a designated pedestrian route to the play area for Health & Safety reasons and there needs to be a way out of it which does not exit onto the car park or the pitch. Possibly the pitch can be changed but Keith felt that wouldn't work as it would then be too small. The path only needs posts on one side and J Bhomick said that the work done did not correspond to the plan the Sports & Social Club had supplied. Mick agreed that the posts will be put in, the gate moved and Gary will provide another plan for the path and the gate which should open outwards from the play area.

PSSC GH

Peter asked why the car park work we did has been criticised so much but the surface on the other side provided by the Parish Council is in a worse state. J Bhomick said the problem was with the car park not being compacted down and, for an extra £300, it could have been. It was pointed out that the surface has stood up very well to the last 6 months wear and tear and the point was also made that the Club had still not received the £1,000 promised from the Parish Council.

Paul pointed out that the cess pit had been made safe when the car park surface was done and faulty electrical cables taken away. It had been intended to do another rolling once the winter was over. J Bhomick said the surface needed more fines and another rolling after that.

R Hamilton-McLeod said that the Club has similar rules and regulations to theirs covering major works and certain guidelines have to be followed, i. e. getting three quotes etc. John said the Club did not need the permission of the Parish Council to do any works, however, if we are asking for funds we do need permission according to O Lister.

	R Hamilton-McLeod suggested giving the Club a copy of the Parish Council rules and regulations. Mick said we have a constitution for	
	licensed premises so it wouldn't apply. She asked for a copy of our constitution and RM will check when Rod Hamilton-McLeod's updated version of June 2002 was approved.	RM
	Mick mentioned the clubhouse costs a lot to maintain with lighting and heating etc and asked if the Parish Council would consider possibly building a new one.	
	Agreed that any future projects will be done in consultation with the Parish Council. O Lister said we have to get their approval before we do anything in future. The impression given to the Parish Council was that the works would be done by a private contractor not on a voluntary basis and, consequently, the VAT would have been absorbed by them.	
	Mick put forward the ideas he thought had been the reason for the meeting. We need another clubhouse but, at the very least, we need new changing facilities - Keith explained the situation on behalf of the footballers and mentioned that there are no female changing facilities. There is now a partitioned off area for the youth teams but its very basic and we need better facilities to encourage them. Mick would like to get the Parish Council involved in the ideas we have for the club.	
	Peter felt we need to formulate something properly and present it to the Parish Council. They have a meeting in November for the following financial year so we should get something to them before then.	
	The electrical cable needs to be buried to a proper depth and we need to find out who did the original work.	·
	O Lister agreed that the £1,000 will be paid over.



The Clubhouse was in need of major refurbishment and all we had at the time was a lot of enthusiasm and no money. In order to fund those improvements the committee successfully applied to Greene King plc for a loan to enable refurbishment to take place on the proviso that the loan had to be guaranteed. You kindly agreed to be a Guarantor and signed the loan document.

During the past ten years, through your goodwill, the Committee has continued to operate the Pirton Sports & Social Club solely for the benefit of the village. Any profits made have been channelled back into improvements, repairs and maintenance and the Parish Council have been very receptive to our applications for grants and other assistance. We have seen major investment in a Multi Use Games Area providing two floodlit tennis courts and facilities for other games which has proved to be a great addition to the village. Unfortunately, other major developments planned had to be shelved when the Government shifted the Lottery Grant 'goal-posts'.

However, none of this could have been achieved had you not agreed, all those years ago, to be one of our Guarantors. Consequently it is with much pleasure we are now pleased to report that this loan has been fully re-paid to Greene King and that the Club is free of any further responsibility in this respect and is in a financially sound position.
